On 3/16/2022, at 2314 HRS., I was recalled to duty by Sgt. Corcoran to investigate a shooting at 50 Sunset Terrace. Sgt. Corcoran advised that a male was shot at that location and was in critical condition.

When I arrived at the Farmington Police Department I met with Sgt. Corcoran and Detective Hughes and was briefed on the incident. I learned that the victim, Jorge Tejada Camacho (DOB 11/7/1990), was shot in his home at 50 Sunset Terrace by Deondre Dominic Linder (DOB 12/10/1997). The shooting was witnessed by Linder's sister, Lyniesha Barber (DOB 4/9/1995). Lyniesha Barber is Camacho's fiancée. All three lived together at 50 Sunset Terrace.

A summary of events is as follows:

On 3/16/2022, at approximately 2256 hours, the Farmington Police Department received a 911 call from a female at 50 Sunset Terrace in Unionville, CT who stated that her brother had just shot her fiancée to death. The caller was identified as Lyniesha Barber (DOB 4/9/1995). Barber identified her brother, Deondre Linder (DOB 12/10/1997), and said that he had used a small handgun to shoot the victim, Jorge Tejada Camacho (DOB 11/7/1990). Camacho was transported to St. Francis Hospital where he died from his injuries. Investigation revealed that the suspect had fled the scene operating a blue Volkswagen Passat bearing CT-AZ09355 (VIN #1VWSA7A39LC014048). The handgun used was not recovered. An emergency cellular phone ping for Linder was requested and was granted. The cellular pings showed the location in a large area which included several hundred meters around 50 Sunset Terrace.

At 50 Sunset Terrace, Officer Santiago interviewed the complainant, Lyniesha Barber. Barber told Officer Santiago that her fiancé, Jorge Tejada Camacho (DOB 11/07/1990), was shot in their bedroom. Barber stated that her brother, who she later indentified as, Deondre Dominique Linder (DOB 12/10/1997) shot Camacho. Barber stated her brother left the house after he shot Camacho. Barber reported that her brother took Camacho's 2020 Blue Volkswagen Passat bearing CT - AZ09355 which was last seen in the driveway of the residence.

The Volkswagen was located by Farmington Police Officer Pacifico Flores on 3/17/2022 at approximately 0005 hours as it was heading eastbound on Farmington Avenue (Rt. 4) in Unionville near the entrance to 1799 Farmington Avenue. Other Farmington Police Officers responded to the area while Officer Flores followed and maintained visual surveillance on the vehicle. The vehicle was followed onto Interstate 84 (I-84) westbound from the exit 39 on-ramp. While on I-84, Farmington Police Officers stopped the vehicle against the guardrail and removed the operator who was confirmed to be Deondre Linder.

While Linder was on the ground being handcuffed, I spoke with Linder to determine if he was injured, and to encourage his compliance. My interaction with Linder was recorded on my Axon body camera and later downloaded to Axon evidence. During that interaction, I asked Linder if he had any weapons on him. He stated he did not. Another officer then asked Linder where the gun was. Linder stated that it was in the car and nodded his head towards Camacho's VW, CT-AZ09355. When I asked Linder a second time if he had any weapons, he again stated it was in the car. Linder cooperated and was compliant during his arrest. Linder confirmed that he was not injured.

Once Linder was secured in handcuffs he was stood up and lead to Officer Bianchi's police cruiser for transport. During that time Linder stated that he would have stayed and told us everything. Linder then stated "I had a reason though".

Linder was transported to the Farmington Police department by Officer Bianchi. I confirmed with Officer Bianchi that he had read Linder his Miranda rights and Linder understood them. I then asked Linder if he understood his Miranda rights. Linder stated that he did. I then asked Linder if he wanted to talk with me about the incident and he stated that he did. Officer Bianchi and I brought Linder to the interview room in the Detective Division. Detective Hughes had set up the recording of the interview prior to my arrival. I brought Linder into the interview room and explained to him that the room was recorded. He stated that he understood.

At 0100 HRS., prior to starting the interview, I read Linder a Farmington Police Department Notice of Rights form. I explained the rights to him and asked if he had any questions. Linder was hesitant and was not sure if he wished to have an attorney present. We asked Linder questions to clarify whether he wished to have an attorney present during questioning. Linder was uncertain and changed his mind several times. I then clarified with him again if he wished to have an attorney present and he stated that he did. We ended the interview. The interview was recorded and later downloaded to a disc as evidence.

Detective Hughes spoke with investigator Jennifer Roberts of the Office of the Chief Medical Examiner. St. Francis Hospital reported to Roberts that Camacho sustained several gun shots wounds. The hospital pronounced Camacho dead at 0009 HRS.

Camacho's VW was towed to the Farmington Police Department and secured in Sally 2 to be processed after the issuance of a Search and Seizure warrant.

Detective Blumetti took a verbal and sworn written statement from Lyniesha Barber. Barber stated that she lived at 50 Sunset Terrace with her fiancé, Jorge Camacho, her brother, Deondre Linder, and her two children, [REDACTED], and [REDACTED]. Barber stated that she was sleeping in bed with Tejada Camacho when she was awakened by her brother's voice saying, "I know what you did". Barber then heard 3-4 gunshots. Barber said that by the light of the gun shots she saw her brother, Linder, holding a silver gun. Linder was wearing a black colored hoodie and a backpack. Barber said that Tejada Camacho sat up in bed and yelled "What". Linder exited the bedroom and shortly after Barber heard the door alarm ring indicating Linder had walked outside of the house. Barber turned on the bedroom light by the wall switch near the door and saw that Tejada Camacho was covered in blood. Barber said that Tejada Camacho's eyes were open, but she knew he was dead. Barber did not know why her brother Linder would shoot Camacho. She stated that Camacho had given Linder two weeks to find a job or move out. Barber a.sc stated that her brother had mental health problems. Barber reported that she was 26 weeks pregnant with Camacho's child. Barber stated that her two children were asleep in another bedroom at the time of the shooting.

In Linder's possession when he was arrested was a Tennessee ID card (#13215245, Birth Certificate and Social Security card in the name of Deondre Dominique Linder 12/10/1997.
