**Affidavit**

The undersigned affiant, being duly sworn, deposes and says:

1. The undersigned, Detective Richard Bango, being duly sworn, does depose and state that he has member of the Shelton Police Department since October 27, 2000. At all times mentioned herein, the undersigned was acting as a member of said department. The following facts and circumstances are stated from personal knowledge and observations, as well as information received from other police officers acting in their official capacity, and from official police reports and statements.
2. On 5/14/2022, at approximately 2354 hours the Shelton Police Department received several 911 calls regarding a fight with multiple victims with stab wounds at 43 Laurel Glen Drive in Shelton. Upon arrival officers located four separate victims on the front lawn of 43 Laurel Glen Drive. It was discovered that the home is owned by Ronald Francis Rich Jr, who was on scene when officers arrived. It was determined that over fifty teenagers were at that home for a house party hosted by Rich's son.
3. Multiple witnesses reported that three to four people who were not invited to the party arrived and exited a dark colored Honda SUV. Witnesses stated the people that arrived in the Honda were from St Joseph's High School in Trumbull. Witnesses further stated that when the parties exited the vehicle a physical altercation with multiple male participants took place on the front lawn of 43 Laurel Glen Drive. During the altercation at least one suspect had a knife and four Victims were stabbed. One of the victims was 17-year-old juvenile with a DOB 12/18/2004 who will here on in be referred to as Juvenile Victim 1, (JV 1). JV 1 was transported by Shelton EMS to Bridgeport Hospital. It was later learned that JV 1 was pronounced deceased at 0110 hours.
4. Sergeant Serrano and Officer Dominguez, noticed all the victims receiving medical attention were in the front lawn area of 43 Laurel Glen Drive. There were multiple people on the front lawn including medical personnel. The entire front lawn was taped off and everyone was removed from that area. Officer Dominguez observed numerous pools of blood, clothing, a sneaker, a backpack and other scattered items on the front lawn.

5. Upon arrival Sergeant Serrano and Officer Dominguez applied for and were granted a search and seizure warrant for the front lawn property of 43 Laurel Glen Drive. Detective Nugent processed the scene and seized the above-mentioned items.

6. Interviews were conducted at the scene with several juvenile witnesses. After speaking with these witnesses they stated the person who stabbed JV 1 was a 17-year-old Juvenile male with a DOB of 06/10/2005. This Juvenile will be here on in referred to as Juvenile Suspect 1, (JS 1). We were also informed that JS 1 was with a 17-year-old male with a DOB of 04/25/2005 who will be here on in referred to as Juvenile Suspect 2, (JS 2). This Affiant also learned that they arrived in a Honda Pilot driven by a 17-year-old male with a DOB 07/26/2005 who will here on in be referred to as Juvenile Suspect 3, (JS 3).

7. On 05/15/2022 at approximately 0200 hours, this Affiant and Officer Eannotti interviewed a 17-year-old male with a DOB of 02/04/2005 who will be here on in be referred to as Juvenile Witness 1, (JW 1). The interview took place in the yard of 43 Laurel Glen Drive and was audio recorded. JW 1's mother was present while speaking with him. JW 1 stated that he was at 43 Laurel Glen Drive that night and he heard his 17-year-old friend, who is later introduced in the affidavit as Juvenile Victim 3, (JV 3), got jumped at a "St Joe's" party somewhere in Shelton. He said later in the night the St Joe's kids showed up at Laurel Glen Drive in a Honda Pilot. He said in the car was JS 1, JS 2 and JS 3 was driving. JW 1 stated he knows the three of them but is not friends with them. He also stated that a female and another male were also in the car. JW 1 stated they parked the car right outside of the house. JW 1 stated that he heard people say that JS 1 was flashing a knife outside the window of the car. JW 1 stated the car then left and went down the road and JS 1 and JS 2 exited the car in the roadway. JW 1 stated he approached them and tried to calm the situation and asked them to leave. He said that while doing this JS 1 had knife in his hand. He stated that JS 1 was holding the knife the entire time he was speaking with him and thought he was trying to scare him. He described the knife as a switch blade kind of knife. He said it was not a hunting knife or big knife. He said he did not get a good look at it but thought it was some kind of pocket knife. JW 1 stated he went back to the party and JS 1 and JS 2 returned to the party a short time later. JW 1 stated JS 1 hit someone first and a big fight started. He stated he saw like twenty five people rolling around on the ground. He said that JS 1 and JS 2 then got up and walked to the car and they drove away. JW 1 stated he saw people were injured after the fight but did not see anyone actually get stabbed.

8. On 05/15/2022 at approximately 0300 hours, Lieutenant Kozlowsky, Officer Eannotti and this Affiant interviewed a 17-year-old female witness with a DOB 10/07/2004. She will here on in be referred to as Juvenile Witness 2, (JW 2). It was learned that JW 2 is currently dating JS 1. After speaking to people at

the scene it was determined that JW 2 may have been in the vehicle with the suspect/suspects involved with this incident. We spoke with JW 2 in the presence of her parents and the interview was audio recorded. JW 2 stated that she attended a St. Joseph's High School party at 5 Lazy Brook Road in Shelton. She stated while there she had heard that some Shelton High School kids were going to show up uninvited. JW 2 stated a few kids from Shelton High School showed up and started provoking the St. Joseph football players to fight. The altercation lasted a short time and the Shelton High School kids left. She stated that some of the kids she was with at the party were then engaged in a group message with Shelton High School kids wherein both sides were bad mouthing each other. JW 2 stated the group of kids she was with knew of the party in Shelton located at 43 Laurel Glen Drive.

9. JW 2 stated that she got into JS 3's vehicle along with JS 1 and JS 2 and two other juvenile males. She stated they then went to 43 Laurel Glen Drive in Shelton. JW 2 stated as they arrived, some of the kids came out of the house and began chatting with them in the car. JW 2 stated shortly after they arrived, she thought someone had thrown an object at their vehicle so they drove down the street. As they pulled down the street, she decided that she did not want to stay at that location so she exited the car and texted her sister to come and pick her up. She stated that JS 1, JS 2 and JS 3 headed back towards the house in the vehicle. JW 2 stated a short time later her sister picked her up. She stated when they were getting in her sister's car with three other persons, JS 3 drove his car back. JS 1 got out of his car and asked for a ride home. She stated while driving JS 1 home he did not mention the fight. JW 2 stated she later heard that JS 1 stabbed someone at the party. She stated she text messaged JS 1 and accused him of the stabbing and she stated he denied it. JW 2 showed this Affiant the text message thread between her and JS 1 which corroborated her statement. Officer Eannotti took photographs of said text message thread.

10. On 05/15/2022 at approximately 1030 hours, Sergeant Millington and Detective Nugent interviewed a 17-year-old male with a date of birth of 09/12/2004, who will here on in be referred to as Juvenile Victim 2, (JV 2). JV 2 was stabbed the night before at 43 Laurel Glenn Drive. JV 2 was interviewed in the presence of his parents and his statement was audio recorded. JV 2 stated that he was at a party on Laurel Glen Drive and two of his friends arrived and stated that they just got jumped by St. Joe's kids at another party. JV 2 stated that moments later, St. Joe's kids showed up at 43 Laurel Glen Drive in an SUV. JV 2 stated that he approached the group of kids and asked them to leave but they refused. One of the two kids threw a punch at their group and a large fight broke out. JV 2 stated he did not know these two persons and has not seen them before. JV 2 stated during the fight he noticed some of his friends were stabbed and he soon after realized he was stabbed in his left arm. JV 2 stated he did not see who had a knife and was

stabbing people. JV 2 went to Griffin Hospital and received five stitches for his laceration. He was released earlier that morning.

11. Sergeant Millington, who is not familiar with the identity of the suspect, showed JV 2 an eight-person photographic array which included a photograph of JS 1. Sergeant Millington then read the Witness Instructions for the identification procedures to JV 2. Sergeant Millington then showed JV 2 the photographic array in sequential order. JV 2 selected photograph number 5, a photograph of JS 1. JV 2 stated that JS 1 was one of the persons that got out of the car and started a fight with their group. JV 2 signed the photograph attesting to his identification.

12. On 05/15/2022 at approximately 1230 hours, Lieutenant Kozlowsky, Officers Eannotti and Muoio and this Affiant interviewed two brothers regarding this assault. The brothers are 18-year-old Thomas Connery Jr and a 16-year-old Juvenile with a DOB of 11/12/2005, who will here on in be referred to as Juvenile Witness 3, (JW 3). We first spoke with JW 3 in the presence of his parents. The interview was video and audio recorded with an Axon body worn camera.

13. JW 3 stated the day before, on 05/14/2022, JV 3 called him and said he went to a St Joe's party at 5 Lazy Brook Lane in Shelton and was jumped by some St Joe's kids. JW 3 stated he then picked up JV 3 and another friend and brought them to the party at 43 Laurel Glen Drive. JW 3 stated a short time later an SUV showed up at Laurel Glen Drive and was driving up and down the road throwing things in the yard. JW 3 stated that he heard someone say, "Yo, those SJ kids are here." He stated that JS 3 was driving, JS 2 was in the passenger seat and a kid he knows by name, JS 1, was also in the car. JW 3 stated that he does not personally know JS 1 but knows of him and has seen him on social media. He also stated that he knows JS 1 dates a Shelton girl. JW 3 stated that the car was racing up and down the street and at one point the car stopped in front of the house. He stated JS 3 was driving and JS 1 and JS 2 got out of the car and they were arguing with the group of Shelton High School kids that were outside at the time. JW 3 stated that JS 1 or JS 2 pushed one of the Shelton kids and the fight started. He stated that at one point everyone was on top of each other and the fight stopped. The group let JS 1 get up and JS 1 started to walk away. He stated JS 1 was walking to the car and everyone was leaving him alone. JW 3 stated no one was going after JS 1 but JV 1 was near him. He stated JS 1 then turns around and takes his knife and stabs JV 1 right in the stomach and pulls it out. JW 3 stated he watched it right in front of him. He said JV 1 lifted his shirt and he was gushing blood. JW 3 said he then heard his brother screaming, "I need stitches." He said he looked over and his brother was bleeding so he ran over and gave aid to his brother. JW 3 stated that he did not see JS 1 stab his brother. He said that JS 1 and JS 2 then drove off in the car





with JS 3 driving. JW 3 stated that he did not get a good look at the knife but did say that JS 1 had the knife on him and did not see him retrieve it from the car.

14. Officer Muoio, who is not familiar with this investigation, later showed JW 3 an eight-person photographic array which included JS 1. Officer Muoio read the Witness Instructions for the identification procedures to JW 3. Officer Muoio then showed JW 3 the photographic array in sequential order. JW 3 then selected photograph number 3, which was a photograph of JS 1. JW 3 stated he was "100 percent positive" that the photograph of JS 1 was the person who stabbed JV 1. JW 3 signed the photograph attesting to his identification.

15. This Affiant then spoke with Thomas Connery Jr. who was released from the hospital earlier that morning. Thomas Jr was stabbed in his leg during this incident. We also spoke with Thomas Jr. in the presence of his father, Thomas Connery Sr. Connery Sr. stated that his son suffered four stab wounds in his left leg. He stated that hospital staff could not stitch his wounds because the knife penetrated his leg so deeply and there was a risk of infection.

16. Lieutenant Kozlowsky, Officer Eannotti and this Affiant then spoke with Thomas Jr. Thomas Jr. stated that he was hanging out at his friend's house at 43 Laurel Glen Drive. He stated that JV 3 came to the party and stated that he was jumped at a St Joe's party on Lazy Brook Road earlier that night. While they were hanging out, someone said that the St Joe's kids were outside. Thomas Jr. stated that the car was racing 80 mph up and down the street and things were being thrown from the car. He stated they were in a Honda Pilot. Thomas Jr. stated the car stopped and JS 1 got out. He stated that he does not personally know JS 1 but knows of him from social media and knows he dates a girl from Shelton High School. Thomas Jr. stated the other person that got out of the car was JS 2. Thomas Jr. stated that he does not personally know JS 2. Thomas Jr. stated that they tried to start trouble and one of them said, "We have a knife on us." He then said he heard someone yell, "Watch out they have a knife." Thomas Jr. stated that one of them, (JS1 or JS 2) threw a punch and they all went over to help. Thomas Jr. stated he went over and was trying to break up the fight up. Thomas Jr. stated while doing this, JS1 was on the ground punching him in the leg and he was trying to kick him off. Thomas Jr. stated that he then saw his whole leg was red and realized that JS 1 was stabbing him. Thomas Jr. demonstrated how JS 1 was stabbing his leg and showed his hand holding the knife in his palm and striking in a downward motion. Thomas Jr. stated he then looked to his left and saw JV 1 take his shirt off. He observed a hole in his chest and saw blood was "shooting straight out." Thomas Jr. stated he saw JV 1 fell to the ground. Thomas Jr. stated he did not see JV 1 get stabbed. He said JS 1 and JS 2 then got in the Honda Pilot and left. Thomas Jr. stated he

17. Officer Muoio, who is not familiar with this investigation, later showed Thomas Jr. an eight-person photographic array which included JS 1. Officer Muoio read the Witness Instructions for the identification procedures to Thomas Jr. Officer Muoio then showed Thomas Jr. the photographic array in sequential order. Thomas Jr. selected photograph number 1 which was a photograph of JS 1. Thomas Jr. stated he was "100 percent positive" the photograph of JS 1 was the person who stabbed him. Upon speaking with JV 3 he stated he was with his friend (who is later introduced in this affidavit as Juvenile Witness 4, (JW 4) the night before. He stated he and JW 4 stopped at a friend's party at 5 Lazy Brook Road in Shelton. JV 3 stated when they arrived, they encountered a group of guys that became argumentative with him. JV 3 stated that he squared off with one of the kids and began fighting in the yard. JV 3 stated that he was winning the fight, when the other kids jumped on top of him and began to hit him. JV 3 stated that he got hit in the nose and got a cut on his head. He stated that one of the guys was holding JW 4 back from helping him. JV 3 stated they were able to get away from these guys and they left. He stated they later went to the party at 43 Laurel Glen Drive.

19. JV 3 stated when he arrived at 43 Laurel Glen Drive, he told his friends about getting jumped and they began to text message some of the kids from the Lazy Brook Road. JV 3 stated a short time of time later the same kids that he got into the fight with on Lazy Brook Road arrived at 43 Laurel Glenn Drive in a Honda SUV. JV 3 stated the vehicle parked in front of the house and the males got out of the vehicle. JV 3 stated that he was in the front yard and began fighting with one of the males from the Lazy Brook Road party. JV 3 stated he was fighting with this kid and at one point he realized he was stabbed and looked up and saw this kid with the knife. JV 3 stated the kid was swinging the knife at people but he did not actually see him stab another person. JV 3 stated he did not know this kid but he believes he could identify him if he saw him again.

20. Sergeant Millington, who is not familiar with the identify of the suspect, showed JV 3 an eight-person photographic array which included a photograph of JS 1. Sergeant Millington then read the Witness Instructions for the identification procedures to JV 3. Sergeant Millington then showed JV 3 the

photographic array in sequential order. JV 3 selected photograph number 5, which was a photo of JS 1. JV 3 stated he was "100 %" sure that JS 1 was the person who stabbed him. JV 3 signed the photograph attesting to his identification.

21. This Affiant later spoke with JV 3's father who stated his son suffered three stab wounds, one on his hip, one near his waist line and another on the left side of his upper torso. He stated that the stab wound on his torso caused a collapsed lung. JV 3 is still hospitalized as of 05/16/2022.

22. On 05/15/2022 at approximately 1530 hours, Detective Nugent and Officer Eannotti met with a 16-year-old male with a DOB 02/11/2006 who will here on in be referred to as Juvenile Witness 4, (JW 4). JW 4 was accompanied by his parents who were present while he spoke with officers. The interview was conducted in the Detective Bureau interview room which is audio and video recorded. JW 4 stated that he went to the party at 5 Lazy Brook Road in Shelton with JV 3. He stated when they arrived, they were confronted by four males and he knew three of them. JW 4 stated the three males he knew were JS 1, JS 2 and JS 3. He stated that a fight started and someone held him back while JV 3 and JS 3 started fighting. JW 4 stated that JS 1 and JS 2 then jumped in and JV 3 was fighting all three of them. JW 4 stated he remembers that JS 1 was wearing a motorcycle helmet at the time. JW 4 stated that they managed to get away and then left. He stated they later went to the party at 43 Laurel Glen Drive. He stated a short time later JS 1, JS 2 and JS 3 arrived in a Honda Pilot. He stated two of them got out of the car and a large fight started in the yard. He said after the three left he saw that some of his friends were stabbed and bleeding. JW 4 stated he did not see anyone actually get stabbed.

23. On May 16, 2022 at approximately 1040 hours Lieutenant McPadden spoke with Dr. Jones from the Office of the Chief Medical Examiner who conducted the autopsy on JV 1. Dr. Jones stated that when she conducted the autopsy there was one stab wound to the left side of the chest. The stab wound went through the rib and the heart. Dr Jones stated there was approximately 1.8 liters of blood in the lungs of JV 1. Dr. Jones stated that the puncture wound was approximately 2 1/2 " - 3 1/2 " deep. Lieutenant McPadden was informed that the cause of death was ruled "stab wound to the torso" and the manner of death was ruled a "Homicide."

WHEREFORE.... the undersigned believes that probable cause exists and respectfully requests that an arrest warrant be issued charging Juvenile Suspect 1, DOB 06/10/2005, with the following, Murder, in violation of CT General Statutes Section 53a-54a and three (3) counts of Assault 1st Degree, in violation
